## 34 Jurisdictions Now Accepting ProCert® with Addition of Rhode Island!

As of August 2018, ProCert certification of continuing education courses and conferences is accepted by Rhode Island for purposes of meeting continuing competence requirements. The Ocean State joins the following jurisdictions also accepting ProCert: Alaska, Arizona, Arkansas, California, Colorado, Delaware,

District of Columbia, Georgia, Hawaii, Idaho, Illinois, Indiana, Kansas, Kentucky, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, North Carolina, North Dakota, Oregon, Pennsylvania, Puerto Rico, South Carolina, South Dakota, Tennessee, Utah, Vermont, Virginia, Wisconsin, and Wyoming.

Several more states are updating their laws and/or rules to accept ProCert certification in the future – potentially by the end of 2018.

### **Nebraska and Washington Award Credit for PTs Completing oPTion®; Washington Promotes aPTitude® in Updated Continuing Competence Model**

Nebraska recently determined oPTion is a qualifying continuing competence activity for PTs in that state and has assigned 3 units of credit for its completion. Nebraska was the 22<sup>nd</sup> jurisdiction to award oPTion credit. FSBPT developed this self-directed assessment tool to assist PTs with periodically ascertaining their knowledge, strength, and opportunities for development. oPTion uses scenarios and multiple-choice questions that emphasize clinical application of knowledge necessary for safe, effective practice.

With rule revisions effective this month, Washington becomes the 23<sup>rd</sup> jurisdiction in which PTs can obtain continuing competence/continuing education credit for completing oPTion (5 units of credit). Additionally Washington will award 2 units of credit for using the aPTitude system to record completed activities.

## In the News

### **“HHS Chief Urges States to Ease Scope-of-Practice Rules -- Also announces tougher regulations for Medicaid drug rebate program,” by Joyce Frieden, Published on *MedPage Today* on August 09, 2018**

“NEW ORLEANS -- States should consider relaxing restrictions on scope of practice and lessening Certificate of Need requirements in order to broaden the free market for healthcare, Health and Human Services (HHS) Secretary Alex Azar told state lawmakers Thursday.

“‘I would urge all of you to take a look at how state and local regulations can be impeding healthcare competition, raising costs for American patients, and depriving them of choices,’ Azar said at a meeting of the American Legislative Exchange Council, a group of conservative state legislators. ‘Regulations like Certificates of Need and scope of practice can have a legitimate purpose. But too often, these rules can be a significant barrier to new competition and lower-cost market disruptors.’

“‘Fundamentally, when we wonder why American healthcare costs so much, why patients feel so disempowered, so often the answer is that government rules are standing in the way of necessary innovation,’ Azar said. ‘As we undertake our efforts to free up competition from the federal level, we hope all of you will examine what can be done in the states.’

Azar was interrupted by applause several times in his 20-minute speech, after which the audience gave him a standing ovation. The first applause came when he said, before outlining his department's top priorities, ‘In each of these areas, one of our first steps is to see how we at HHS can get out of the way: how we might be inhibiting innovation by state governments and private actors.’”

### ***The Physiotherapy Standards framework 2018* by the Physiotherapy Board of New Zealand**

“The Physiotherapy Board (Board) have developed the Physiotherapy Standards framework to provide a benchmark of minimum standards expected of registered physiotherapists in New Zealand. The Board operates under the Health Practitioners Competence Assurance Act 2003 (HPCAA) whose principle purpose is to provide mechanisms to ensure physiotherapists are competent and fit to practise and most importantly protecting the health and safety of the New Zealand public.” Read the report [here](#).

### **“App to Alert Californians When Physicians Are Disciplined”, By Alicia Ault, Published in *Medscape* on Jul 27, 2018.**

“Californians can now get almost instantaneous notice when a physician's license has been suspended or revoked or when some other disciplinary action has been taken against a doctor.

“The notice, which will come via an app, was unveiled by the Medical Board of California at a news conference on July 26. The board developed the app to build on a 2-year-old public information campaign that has been encouraging consumers to keep tabs on their physicians by periodically checking the board's website.

“Now, any state resident with an iPhone or iPad can install the free app and receive push notifications on physicians they choose to ‘follow.’ Users can follow as many as 16 physicians at once.”
