This year, nine administrators and three board attorneys attended the training.

Next year's training will again be held in Alexandria, Virginia June 24-26, 2016. Attendees rave about the quality of the topics and the presenters. FSBPT funds attendance at this meeting.

Leadership Issues Forum (LIF)

The Leadership Issues Forum was held in Alexandria, Virginia August 1-2, 2015. Topics included the Licensure Compact; Continuing Competence, the Coursework Tool; Dry Needling Competencies; the Exam, Licensure and Disciplinary Database (ELDD); NPTE Eligibility; Public Awareness, Physical Therapy and Regulation; and Minimum Data Set. Fourteen administrators attended this meeting.
