## 2015 Slate - are you interested in running?

This year, the FSBPT Nominating Committee will be slating individuals for Secretary, Treasurer and Director on the Board of Directors and a member of the Nominating Committee.

Requirements for Secretary and Treasurer: Member of a Member Board, administrator of a
Member Board, or an Associate Member. Associate Members are former Members or
Administrators of a Member Board, former members of the Board of Directors, former
committee or task force members or members of the Academy of Advanced Item Writers.

- Requirement for Director: Current member of a Member Board at the time of the election.
- Requirement for Nominating Committee: There is no bylaws requirement for the Nominating Committee position, but candidates need to be familiar with the organization and have interacted with Federation members at various meetings.

# NPTE withdrawal, score transfer and individual score report fee changes

#### **NPTE Withdrawal Fees**

Withdrawal fees will change slightly this year. The current withdrawal fee for the NPTE is \$50.

Starting in the fourth quarter of 2015, the withdrawal fee will stay \$50 if the candidate withdraws 30 days or more in advance of the exam. If the candidate withdraws less than 30 days prior to the exam, the fee will be \$100.

Note that NPTE withdrawal fees have been \$50 since 2004.

#### **Score Transfer Fees**

Currently the first transfer is \$80 and subsequent transfers are \$55. On March 1, 2015, all score transfers will be \$80.

## **Individual Score Reports**

Also, on March 1, 2015, Individual Score Reports (ISR) will increase from \$55 to \$80.

Candidates can continue to view and download free ISRs by going to <u>Status of My Request</u> 10 days after their test date. The free reports remain viewable for 30 days.

The last score transfer and individual score report fee increases were in 2009.

### Physical Therapy Licensure Compact – the latest news

The Physical Therapy Licensure Compact Draft nears completion. The Compact Drafting Team had its third meeting in January and will soon have a complete draft of the licensure compact language.

A call for comment will be made after its final meeting in April.

Any revisions based on stakeholder comments will be made via teleconference. The Team is proud of the work they have done and believe the language is close to what will be best for consumers of physical therapy as well as the profession. Stay tuned for dates and times of educational webinars and articles on the details of the compact this spring.

# Online on-demand JAM launching soon

In February 2015, FSBPT will launch a new learning tool developed first for the New Jersey State Board of Physical Therapy. The New Jersey Jurisprudence Assessment Module (NJ JAM) is required for initial licensure and also awards 1.5 credits of continuing competence credit towards meeting jurisprudence and ethics requirements for renewal.

The NJ JAM is an online and on-demand timed module that must be completed in 90 minutes. Takers are required to answer 80% of the questions correctly to pass and are permitted two attempts to pass. While completing the NJ JAM, takers can review New Jersey physical therapy practice regulations.

FSBPT just conducted an Item Writing Workshop for JAMs for California, Hawaii and New Hampshire.

Your board may want to consider JAM for initial licensure or both initial licensure and renewal.

Contact <u>competencestaff@fsbpt.org</u> to request additional information. FSBPT staff can demo the JAM at your board meeting either in person or via an internet-based presentation.

Interest in JAM is high and the development timeline requires some time to accomplish, so please register your interest as soon as possible.

## Interested in continuing competence? Apply to be a volunteer reviewer for ProCert!

FSBPT's ProCert program evaluates continuing competence activities and awards certification to those that meet the FSBPT Standards for Continuing Competence.

ProCert certification renders those activities as accepted by licensing boards in 21 jurisdictions for purposes of meeting renewal requirements.

Acceptance is anticipated to grow to several new states in 2015.

## **Next Training- Spring 2015**

To fulfill the growing demand for this service, FSBPT is accepting applications to train volunteers to serve as ProCert reviewers (dates to be announced).

The training is held in the FSBPT office in Alexandria, Virginia. FSBPT covers participants' travel, hotel and meal expenses.

This opportunity requires a two-year commitment of approximately two to four hours weekly to conduct two to four activity reviews.

Training is "hands-on" during which participants are taught how to use the ProCert review system within aPTitude. Participants also conduct several practice evaluations of activities.

# Cheating in the News: Ex-Chiropractor gets 12 years, \$2.4M fine for Blue Cross fraud

Jessica Corso reported on January 6, 2015 at Law360, "A former chiropractor will spend 12 years in jail and pay \$2.4 million after a Texas federal judge sentenced him on Monday for his role in billing a <u>Blue Cross Blue Shield</u> unit and other insurers for services he had never performed, according to a statement released by the <u>U.S. Department of Justice</u>.

"Dr. Abbas Zahedi was convicted by a jury in June of 10 counts of health care fraud and related charges after he conspired with a former union representative at Lear Corp. to provide kickbacks to workers who agreed to bill their insurers for medical services they had never received."
