#### Licensure Compact Update

Thirteen states are indicating they will move forward with the Physical Therapy Licensure Compact (PTLC) in 2017. These jurisdictions include: Colorado, Florida, Georgia, Kentucky, Mississippi, Montana, New Hampshire, New Jersey, North Carolina, North Dakota, Oklahoma, Utah, and Washington.

In anticipation of the activation of the Physical Therapy Compact later this year, FSBPT completed the Article of Incorporation for the Licensure Compact Administration Services Corporation in December 2016.

  a unified professional educational model, accreditation and the need for assessment of professional
  education standards, credentialing assessment of education standards, disciplinary processes,
  professional databases (licensure, exam, discipline, practice settings) and continuing professional
  development models

### 30<sup>th</sup> Jurisdiction confirmed acceptance of ProCert certification!

The end of 2016 delivered the exciting news that **Puerto Rico** became the 30<sup>th</sup> jurisdiction to confirm acceptance of ProCert certification of continuing education courses and conferences. Any ProCert certified activity will be accepted by the board for purposes of meeting continuing education and licensure renewal requirements for PTs and PTAs in Puerto Rico.

The list of ProCert accepting jurisdictions now consists of: Alaska, Arizona, Arkansas, California, Colorado, Delaware, District of Columbia, Georgia, Hawaii, Idaho, Illinois, Indiana, Kansas, Kentucky, Michigan, Mississippi, Missouri, Montana, Nebraska, North Carolina, North Dakota, Oregon, Puerto Rico, South Carolina, Tennessee, Utah, Vermont, Virginia, Wisconsin, and Wyoming. Several more states are updating their laws and/or rules to accept ProCert certification in the future – potentially by the end of this year. FSBPT's ProCert program evaluates continuing competence activities and awards certification for those that meet the FSBPT Standards for Continuing Competence. ProCert certified activities are accepted in 30 jurisdictions. To fulfill the growing demand for this service, FSBPT is accepting applications to serve as volunteer ProCert reviewers. The next ProCert reviewer training will take place April 7-8, 2017 at the FSBPT office in Alexandria, Virginia. FSBPT covers participants' travel, hotel and meal expenses. #### Step One on Your Journey to the 2017 Leadership Issues Forum (LIF) and Annual Meeting

Member board chairs and administrators, add elections to your next board meeting agenda! We will need your delegates elected and your funded administrator designated **by May 15, 2017**. Are you new to the Leadership Issues Forum and Annual Meeting journey or perhaps unsure why you need to hold elections?

The <u>bylaws</u> require that those who serve as delegates or funded administrators at the Delegate Assembly be elected by their respective boards.

We ask boards to elect one person to serve in each of these roles (if feasible):

- Voting delegate- casts the jurisdiction's vote in the Delegate Assembly for motions and elections
- Primary alternate delegate- serves as the voting delegate should the elected voting delegate not be able to attend
- Funded Administrator- can serve as the voting delegate for jurisdictions that do not elect delegates

In 2017,

- FSBPT will fund the voting delegate and funded administrator to attend the Leadership Issue Forum July 29-30 in Alexandria, Virginia, and
- FSBPT will fund the voting delegate, the primary alternate delegate and the funded administrator to attend the Annual Meeting November 2-4 in Santa Ana Pueblo, New Mexico

FSBPT offers a legislative tracking tool that allows members to monitor legislative activity in a jurisdiction.
