"Board Certification: A Dose of Competition", by Daniel J. Gilman, Brian J. Miller and Brian Goldstein, Published on *Health Affairs* website on November 29, 2017

"In 2014, internists went into open revolt in response to the American Board of Internal Medicine's (ABIM) new maintenance of certification (MOC) program (a model of measuring continuous learning). The ABIM required physicians to undergo an assessment every two years and a 'high stakes' recertification exam every ten. Internists balked, questioning this new and costly requirement.

"Subsequently, internists and other physicians began to question the long-held dogma that board certification promotes higher-quality, safer care, and they began to examine the private monopoly of the American Board of Medical Specialties (ABMS). Three years later, significant effort and research has revealed the imbalance between certification requirements that impose costly entry barriers for physicians and the limited quality benefits and information for consumers that result.

"A two-sided market, board certification provides independent attestations of specialized training to both physicians and consumers of physician services. Hospitals frequently require board certification for granting specialty-specific privileges, thus forcing physicians to purchase not only certification, but also MOC and re-certification from a near-monopoly market as a means of access to continued employment. Patients face increased costs and limited offsetting benefits typical of monopoly markets—recent health care services research has demonstrated no incremental quality gains from MOC and re-certification.

"The ABIM's MOC endeavor and its aftermath highlight the need for certification that is designed for and tied to clear quality benefits for patients. This can be achieved through increased competition in the private market for physician board certification, driven by increased antitrust oversight of certifying boards, hospital flexibility in physician credentialing, and joint stakeholder development of gradations of certification tied to meaningful clinical outcomes."

"Physical Therapy Burnout is Destroying Our Profession", by Meredith Castin, Published on *Covalent Careers* website on October 18, 2017

"Jeannette Lang* met me for dinner after a long day at the clinic. As the sun dipped behind the restaurant, I realized that it was already approaching 7:45 on this balmy summer night. 'Sorry,' she sighed, as she slid into her seat. 'My last patient was 20 minutes late, and I had to finish some charting before I left.'

"After I assured her everything was fine, we started catching up on life.

"Lang had been working two jobs since we graduated from PT school together in 2010. On weekdays, she worked from 10-7 for a chain of busy outpatient orthopedic sports clinics, often seeing up to 30

patients per day. Every other weekend, she worked a per diem acute care shift for a major hospital. She spent her lunch breaks charting, contacting doctors' offices, and completing other work-related tasks that would otherwise cut into her productive patient care time. On her days off, Lang frequently visited the coffee shop near her apartment, spending hours of unpaid time catching up on documentation.

"She was always tired, but she saw no end in sight. 'I'm still working on paying off my PT school loans,' she explained.

"Lang is generally the picture of health; a former fitness model, she has competed in multiple triathlons, eats well, and works out on most days. But when we met for dinner, I noticed that she had developed an acne problem, and she revealed that she had recently contracted shingles. While she loves physical therapy and enjoys patient care, she had been struggling to prioritize her health, and she told me she was feeling burned out as a result. She and her boyfriend would love to get married, but they wonder how they will ever pay for a wedding and how they will afford to care for children.

"Sadly, Jeannette Lang's story is not unique. Many physical therapists work well over 40 hours per week and are uncompensated for the overtime, even when they're paid as hourly employees. Yet, these same employees are subject to being 'flexed off' during slow days, which costs them either time or PTO."
