FSBPT-APTA aPTitude® Partnership Update

In January, FSBPT and APTA announced a new partnership to make APTA's complete catalog of learning activities available in aPTitude to improve the PT/PTA/student experience in searching for and recording APTA activities. Nearly 350 sessions of APTA's Combined Sections Meeting (CSM) 2018 were imported into aPTitude and about 73,000 PT/PTA/student attendance records were verified for those sessions. More recently all sessions offered at APTA's NEXT Conference & Exposition 2018 were imported into aPTitude and close to 8,000 attendance records were verified in the system.

News from the Nevada Board

Nevada has adopted the FSBPT Continuing Competence Model and will fully implement aPTitude for use by all licensees when updated regulations are ratified within the next 6 months. Nevada is adopting the use of the JAM and is in the process of finalizing with FSBPT to require successful JAM completion at

initial licensure and in every year ending in 5 and 0. Two continuing competence units (CCUs) will be awarded for achieving a passing score on the JAM. Nevada has also approved 8 CCUs for any licensee taking oPTion; this activity can be completed every 5 years.

In other news Nevada is introducing legislation during the 2019 legislative session to adopt the PT Compact. Additionally the Nevada board has its first ever PTA board appointment as a result of a recent statute change. Finally, the Nevada board is planning a strategic planning session at its March 2019 meeting.

The educational program will focus on: Regulatory Board Governance and Effectiveness; Mobility, Workforce, and Technology; Ethics, Standards, and Scope of Practice; and Regulatory Innovations and Issues. The meeting will include speakers from around the world who provide insight into various models and approaches to regulation. There will be a keynote speaker, small group sessions, and rapid

In the News

"New Occupational Licensing Analysis Opposes Traditional Theory", Published on The Council of State Governments website June 5, 2018

"Washington D.C., June 5, 2018 – Restrictions to employment opportunities and wage inflation of license holders are arguments commonly tied to occupational licensing. However data collected by the Bureau of Labor Statistics (BLS) and analyzed by The Council of State Governments (CSG) found that licensing had no such effects. As a result of this study the CSG recommends 'enhancing portability of state licensing and creating more a more equitable system for vulnerable populations like veterans and military families, people with criminal records, immigrants, and long-term unemployed workers is a crucial need. However, it is not clear from this evidence that deregulation will have the economic impacts that some believe'. The CSG further suggests 'perhaps policymakers should focus their efforts on things other than deregulation when figuring out how to grow their state economies'."
