Leslie Adrian, PT, *Director of Professional Standards for the Federation of State Boards of Physical Therapy*



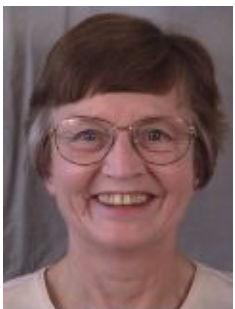

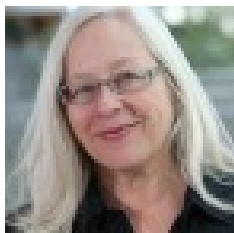
