

Have you ever had to move with a few months let alone a few days' notice? Have you had to sign up for professional licensure with the hope of expedited processing only to have to wait months until you are able to work? Thirty-six percent of military spouse professionals must relicense each time they move to a new state with their active-duty spouse. The military provisions added to most occupational licensing compacts address the unique considerations military spouses and family members have as physical therapists and physical therapist assistants with relocation and licensure.
